The meeting was called to order on Zoom at 5:02 PM PDT.

A quorum was present.

1. Approve the minutes from the previous meeting – Claire Schneider

Motion 1: to accept the minutes of the July 22, 2020, teleconference with corrections. Motion by Bonnie Nichols and seconded by Michelle Snyder. Passed unanimously.

There was a discussion about the quantity of discussion reported in the minutes.

#### AIS SPRING REPORTS

## 2. Awards - Gerry Snyder

There was a discussion about how visits to gardens and voting the AIS Ballot would be handled in 2021 if the COVID-19 restrictions remain in place. Wayne Messer and Gerry Snyder were asked to organize a group of people to plan contingencies for voting the AIS Ballot next year. Bonnie Nichols, Mike Reed and Andi Rivarola volunteered to participate in this ad hoc committee.

#### 3. Exhibition Shows - Wayne Messer

There was a discussion about how shows would be handled in 2021, if the COVID-19 restrictions remain in place during the show season next year. One suggestion was for the AIS Board to approve a set of criteria that, if followed, would allow a virtual show to be sanctioned. It also was suggested that we investigate how other iris affiliates and other garden and flower clubs are handling shows and awards during the COVID-19 restrictions.

#### 4. Exhibition Supplies - Nick Stewart

Nick described his process for purchasing more show entry tags. Before finalizing the purchase, Gary White and Lois Rose will discuss changes to the wording on the show entry tags and forward that information to Nick.

#### 5. Symposium - Riley Probst

Howie Dash will send out a reminder to the RVPs to have the results of the regional balloting sent to Riley by September 1<sup>st</sup>. Riley plans to present the results of the 2020 Symposium at the November AIS teleconference.

# 7. Iris Images - Neil Houghton

Motion 2: Image Requirements for AIS Introduction

#### Resolution:

- 1) Effective for 2021 Introductions, images are required before or with the introduction of an iris cultivar. Images submitted with registrations are encouraged. Images submitted with registration will satisfy the above requirement when and if the iris is introduced.
- 2) Images should be submitted to the AIS Image Coordinator.
- 3) Images must be free of watermark or other text. Name of the registrant, name and class of cultivar, date of introduction, and photographer must should be included in the filename for proper identification and credit.
- 4) These images should be of the highest resolution available. AIS would like an image of at least 1 MB (1000 KB). There is no upper limit except for the practicality of submission.
- 5) One image of the bloom is required. Up to 5 images may be submitted. These may include: another view, the clump, the stalk and/or a close-up of a distinguishing feature.
- 6) If a registrant is not capable of complying with this requirement, a written request, detailing the reason(s) an exemption is being sought, must be submitted to the AIS Image Coordinator prior to the exemption being considered.
- 7) If a photo is not included with introduction (or registration) or an exemption has not been requested and received, the iris shall not be considered an official introduction for the purposes of entering the AIS Awards System in the United State of America or Canada.

Motion by Neil Houghton and seconded by Howie Dash. Motion, as amended, is carried.

Discussion: "Introduction" according to current policy is offering for sale of the iris. Offers of iris made on Facebook and social media are not the same as those made in catalogs or websites. Therefore, irises posted for sale on Facebook and social media would not have met the standard for introduction. The discussion of introduction continued. The limit on a filename of a photo is 250 characters. The discussion of filename continued. A discussion of compliance took place. John Jones, Wayne Messer and Jody Nolin will continue to confer about establishing a Constant Contact forum for hybridizers.

### 8. Webinar update - Andi Rivarola

Attendance is increasing, even someone from New Zealand. Planning for the Winter Series of webinars has begun. A discussion of how the webinars will be used and archived ensued. Three questions regarding the judges training were addressed.

### 9. Membership Development Committee update - Andi Rivarola

Results of their first survey have been published. A second survey has been put out on News & Notes.

# 10. COVID-19 impact on bylaws - Gary White

Restrictions and mandates from local, state and federal governments due to the COVID-19 pandemic have interfered with the bylaws of some AIS affiliate clubs, sections, societies and regions. Dale Strauss, the AIS counsel, has produced a sample amendment that could be sent out to the affiliates, sections, societies and regions that would address this omission from the bylaws. In addition, Dale wrote a set of rules that could be applied to electronic meetings. Gary will send members of the AIS Board of Directors copies of the documents that Dale Strauss has provided and this topic will be addressed at the next teleconference. A discussion of the process of amending bylaws ensued.
